**RESTRICTION OF RESALE :** From and after Jan. 1, 1979, the lots sold by this municipality shall not be further sold, transferred, conveyed or assigned to any person except the municipality. The municipality agrees to buy back any cemetery grave lot which it may hereafter sell. The repurchase of such lots shall be for the original price paid by the purchaser, or the current selling price of the lot, whichever is less unless otherwise authorized by the governing body. The original certificate of lot ownership must be surrendered at the time of resale to the municipality.

- \* If the lot owner is deceased before lots purchased are used, and unless otherwise decreed in a will by the lot owner, any unused burial lots would be under the direction of the current spouse, if no spouse, direction would then go to **all** living children of the lot owner. If there are no living children of the lot owner, **all** other living immediate family members must agree on lot use. Lot ownership will not be transferred, this direction will only clarify to the municipality permission of lot use.
- \* As long as the lot owner is living, permission for burial use can be changed as needed. Direction of lot use by the lot owner is primarily for instruction to the municipality if the lot owner is deceased. Direction for lot use by the lot owner will also give all living family members instruction as to who should have the right for use of the burial lots purchased by the lot owner.
